

PERSONAL DATA PROCESSING REGULATIONS

adopted for the site <https://www.castelli-fantasma-leggende.it>

This site processes data mainly on the basis of the consent of users. The consent is given through the banner at the bottom of the page, or through the use or consultation of the site, as the concluding behaviour. By using or consulting the site, visitors and users approve this privacy policy and consent to the processing of their personal data in relation to the methods and purposes described below, including any disclosure to third parties if necessary for the provision of a service. By means of the communication or service request forms, further consents relating to the specific purpose of the service are collected.

The provision of data and therefore consent to the collection and processing of data is optional, the User may deny consent, and may revoke at any time a consent already provided (through the banner at the bottom of the page or browser settings for cookies, or the link "Contact"). However, denial of consent may result in the inability to provide certain services and the experience of browsing the site would be compromised.

Data for the security of the site and for the prevention of abuse and SPAM, as well as data for the analysis of site traffic (statistics) in aggregate form, are processed according to the legitimate interest of the Data Controller to protect the site and the users themselves. In such cases the user always has the right to oppose data processing.

The data provided for consultancy or professional assignments are processed on the basis of the fulfilment of a contract and the fulfilment of a legal obligation.

The site may collect other data in case of voluntary use of services by users, such as comment services, communication services (contact forms, boxes, comments), which will be used exclusively for the provision of the requested service:

- name
- email address
- any additional data sent voluntarily by the user.

We process the data of visitors/users in a lawful and correct manner, taking appropriate security measures to prevent unauthorized access, disclosure, modification or destruction of data. We are committed to protect the security of your personal information when sending it, using Secure Sockets Layer (SSL) software, which encrypts information in transit. The processing is carried out by computer and/or telematic means, with organizational methods and logics strictly related to the purposes indicated. In addition to the Owner, in some cases, categories of persons involved in the organization of the site or external parties (such as third party technical service providers, hosting providers) may have access to the data.

This site makes use of the following categories of cookies:

- technical cookies, used for the sole purpose of transmitting an electronic communication, to ensure the correct display of the site and navigation within it. In addition, they allow to distinguish between the various users connected in order to provide a service requested to the right user (Lo-gin), and for security reasons of the site. Some of these cookies are deleted when the browser is closed, others have a longer duration (e.g. the cookie for storing user consent lasts 1 year).
- analysis cookies, used directly by the site operator to collect information, in aggregate form, on the number of users and how they visit the site. They are assimilated to technical cookies if the service is anonymous.

By clicking "OK" on the banner on the first access to the site or browsing the site, the visitor expressly consents to the use of cookies and similar technologies, and in particular to the registration of these cookies on his terminal for the purposes indicated above, or to the access to information on his terminal through cookies.

The user may refuse the use of cookies and at any time revoke a consent already given. Since cookies are linked to the browser used, they MAY BE DIRECTLY DISABLED FROM THE BROWSER, thus refusing/withdrawing consent to the use of cookies, or placing a banner at the bottom of the page.

DISABILITATION OF COOKIES MAY PROHIBIT THE CORRECT USE OF ANY FUNCTIONS OF THE SITE ITSELF, in particular services provided by third parties may not be accessible, and therefore may not be viewable:

- social network social buttons
- Google maps.

In accordance with European Regulation 679/2016 (GDPR) the User may, in the manner and within the limits provided for by current legislation, exercise the following rights:

- oppose in whole or in part, for legitimate reasons, the processing of personal data concerning him/her for the purpose of sending advertising materials or direct selling or for carrying out market research or commercial communication;
- request confirmation of the existence of personal data concerning him/her (right of access)
- know its origin
- receive intelligible communication
- have information about the logic, methods and purposes of processing
- request the updating, rectification, integration, cancellation, transformation into anonymous form, blocking of data processed unlawfully, including those no longer necessary for the purposes for which they were collected
- in cases of processing based on consent, to receive, at the sole cost of any support, the data provided to the data controller, in a structured and readable form by a data processor and in a format commonly used by an electronic device, if any.
- the right to submit a complaint to the Italian Data Protection Authority
- as well as, more generally, to exercise all the rights granted to him by the current legal provisions.

Requests must be addressed to the Data Controller.
